HART, MICHIGAN - 2008

Dear Arts & Crafter Exhibitor:

You are invited to participate in the National Asparagus Festival Arts and Crafts show on June 13 and 14, 2008 in Hart, Michigan. The show is open to all professional and amateur artists and craftsman.

Workmanship must be the exhibitor's own original design and execution. **NO COMMERCIAL BOOTHS. A photograph of the work you intend to sell will be required.** This photograph will help us with booth assignments so that similar crafts will not be positioned next to one another. We are striving to have all items "for sale" handcrafted. We know that some of you who purchase from mass production might be disappointed, however, our hope is always to be a genuine arts and crafts fair. Misrepresentation will lead to you being asked to leave the show.

The **fee per 12'x12'** site will remain at **\$45**. Please make **your check** or **money order payable to the National Asparagus Festival. This fee is non-refundable.** A non-sufficient fund check will result in an additional charge of \$28. **The application deadline is Friday, May 23, 2008.** Confirmation letters including directions, schedule of events and an accommodations list will be sent to you after May 23.

Your Hart fair location will be held on the Courthouse lawn as it has for many years when festival activities take place in Hart

The **fair** will be held on Friday, June 13<sup>th</sup> (11 a.m.- 5 p.m.) and Saturday, June 14<sup>th</sup> (9 a.m. – 5 p.m.). **Set-up times** will be Thursday, June 12<sup>th</sup> (4 p.m. – 8 p.m.), Friday, June 13<sup>th</sup> (8 a.m. – 11 a.m.) and Saturday, June 14<sup>th</sup> (7 a.m.- 9 a.m.) We strongly encourage two-day participation, but will accept one-day exhibitors. Space will be assigned on first-come, first serve basis. Spaces will be guaranteed by early payment received prior to the application deadline (**May 23**). Exhibitors must provide their own means of displaying their works and must have a responsible person in attendance at all times. The NAF will not assume responsibility for any damaged or lost works. Be prepared for rain or shine! **NO electricity will be available.**
